From New Market, take US 211 east for about 5 miles. Turn left on FDR 274 (Chrisman Hollow Road) at the top of the mountain and proceed north for 8 miles to the trailhead parking area.

Camp Roosevelt Recreation Area, site of the first Civilian Conservation Corp Camp in the Nation is 1.5 miles from the trail on SR 675.

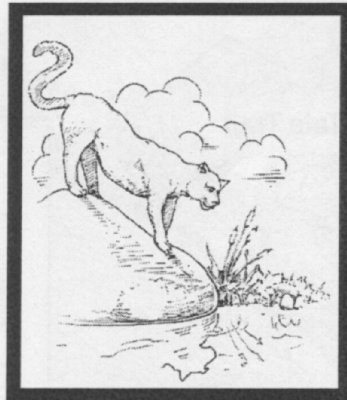
Story Book Trail, 8 miles south of Lions Tale Trail on FDR 274. A paved 0.5 mile trail with a fabulous overlook.

Come explore the Lion's Tale Trail. Your guide, Lop Ears, the mountain lion, will tell you secrets about this forest and encourage you to explore the forest using your sense of hearing, smell, touch and sight. You will visit fifteen different interpretive stops to learn about forest ecology.

Ever wonder what a bee tree and a wildflower meadow have in common? On the trail you can listen for the music of insects in a wildflower meadow or take your shoes off and wade in a cool mountain stream. You can also enjoy the sounds of Passage Creek and smell a soggy boggy place as the trail winds through the forest.

Designed to be Accessible

The Lion's Tale National Recreation Trail is the only universally accessible trail on the George Washington National Forest.

Designed to provide a sensory experience, this 0.5-mile easy trail stimulates the senses of smell, hearing, touch and sight.

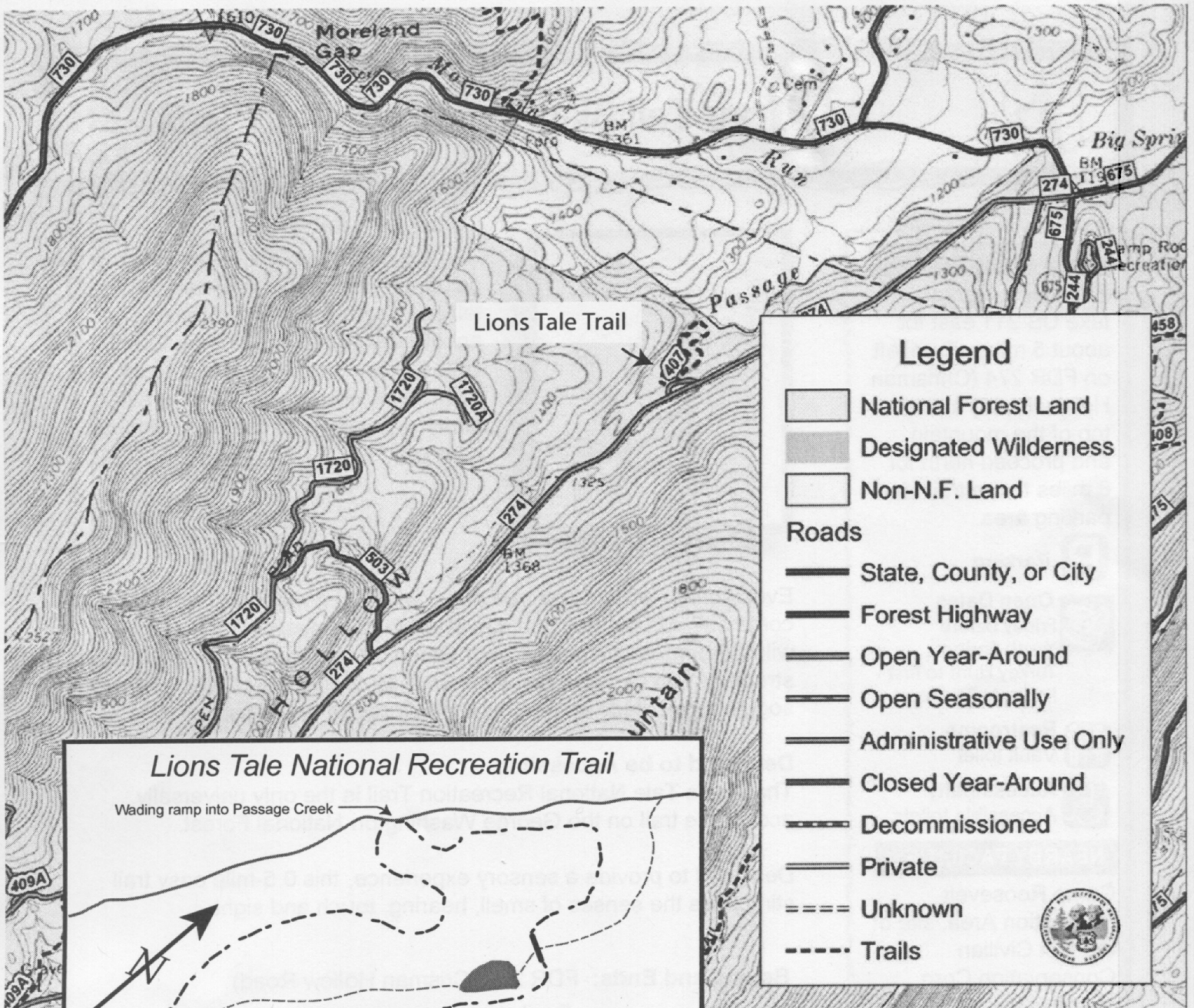
